CiDir is a specialized corporate governance course that provides individuals with knowledge, skills and insights into the responsibilities and functions of corporate directors. The program is designed to prepare individuals for board-level roles in various organizations, including public companies, private firms, non-profits and governmental entities.

This Programme is targeted at: Directors/Prospective directors (commissioners/members of advisory boards); Corporate Secretaries; Accounting officers; Senior Executives; Senior Management; Audit Partners/Managers; Governance Consultants and corporate leaders across the board.

It is a 5-days in house course comprising 16+ modules which aim at transforming the Tanzanian director into corporate governance professional at the stage of his career where he is required to display knowledge and expertise in relation to:

"Governance outlook and ethics; Constituting a better board with effective board processes; Supervision of the organization's financial performance and risk management; Examining directors' responsibilities, fiduciary duties and compliance roles; Establishingboard's position to the performance, strategy development and its execution; Reviewing frameworks for board decision-making"



CiDir Programme Objectives:

The CiDir program aims to provide participants with a comprehensive understanding of corporate governance principles, effective board roles and responsibilities, strategic governance, financial literacy, and legal compliance, The broad Objectives of the CiDir Course are to:

MODULES

Module 1: Introduction to Corporate Governance & Compliance Issues

Aims at creating and enhancing awareness of corporate governance principles and underlying international best practices; It gives an overview of the principles of corporate governance and introduction to governance codes specifically King's Report.

Module 2: The Roles & Responsibilities Essentials for The Directors

Provides essential understanding, characteristics and benefits of the Effective (balanced) Board versus those of a dysfunctional board; Identify, develop and articulate solutions to improve board's effectiveness; Board's composition, structure, purpose, tasks and roles; Directors' duties and responsibilities.

Module 3: Strategy Essentials & The Strategic Role of The Directors

Covers and examines the board's role in governing corporate strategy and good practices in strategy formulation, implementation and monitoring.

Module 4: Essentials of Financial Numeracy

Covers and examines the financial oversight role of the board; Understanding, analysis, interpretation of company's financial position (statements) and its basis on Board's decision-making and strategic condition; Analysis of the financial statements and their relation to liquidity, profitability, and performance.

Module 5: Introduction To Legal & Regulatory Environment and The Duties of Directors

Aims at imparting an essential understanding of duties, powers, responsibilities and liabilities of a director, their consequent liabilities and remedies thereof. It gives insights to the relevant legislation including the 2002 Companies' Law and related legislation plus implications

Module 6: Risk Essentials and Issues for Directors

An introduction to the concept and of risk and its nature; The Board's role in risk management and process; an introduction and discussion on the changing landscape of the Tanzanian public and private enterprise as a feature of Tanzanian

Module 7: In The Boardroom – Board Dynamics & Soft Skills

Examines and introduces the best practices associated with directors' interaction within and outside the board; board procedures, Creative thinking; soft skills and business ethics.

Module 8: Introduction to Governance of State-Owned Enterprises (SoEs)

This module covers a critical aspect of managing entities owned, controlled, or significantly influenced by the government. SoE governance aims at ensuring that SOEs operate efficiently, transparently, and in the public interest. This module is lecture based with Boardroom practices plus numerous and extensive case studies covering the essential knowledge and skills for an enterprise director in the global market

Module 9: Introduction to ICT Governance and Oversight

Focuses on equipping participants with the fundamental knowledge required for effective ICT governance: Board's Oversight and aligning IT strategies with organizational goals. Participants will understand the significance of ICT governance and be adept at selecting and applying key strategies for effective IT governance.

Module 10: Introduction to Cybercrime for Directors

Provides a concise yet comprehensive overview of cyber security essentials, tailored specifically for directors. Covering the legal fundamentals of cybercrime. By the module's end, directors will be equipped to understand, address, and navigate the legal landscape of cyber threats, contributing to

Module 11: Introduction to Procurement Governance for Directors

Offers directors with a practical overview of procurement governance essentials. Covering key topics such as distinctions between private and public procurement, and the institutional setup in procurement, governance risks, and explores audit findings from the CAG in a context of procurement governance.

Module 12: Human Resource Essentials for Directors

This module covers HR governance and HR management integration, clarification of directors' HR responsibilities, legal compliance and risk management considerations, exploration of HR metrics, and practical tips. Participants will understand the crucial connection between governance and HR management, recognize and fulfill their HR responsibilities, and comprehend legal compliance nuances

Module 13: Employment and Labor Relations Essentials for Directors

Topics include fundamental concepts, commencement processes, applicable law determination, probationary employment, effective management, and compliant conclusion of employment relationships. By the module's end, participants will possess essential knowledge for legally sound and strategic human resource practices in the context of their directorial roles.

Module 14: Introduction to Stress, Conflict & Change Management

Participants will delve into facts about stress, change, and conflict management, understanding sources and effects of stress, and learning to identify signs of stress. The module also equips directors with conflict management strategies, emphasizing the importance of these skills in fostering a healthy organizational culture.

Module 15: Protocol & Etiquette Essentials for Directors

Provides a broad overview of basic principles of protocols and etiquette tailored for directors, including diplomatic protocols and their relevance. Directors will gain understanding basic protocol and etiquette principles, comprehend the significance of protocols, and acquire the skills to navigate the corporate and professional world with finesse

Module 16: Board Simulation – Real-life Practice in the Boardroom

It is the convergence of all the concepts, tools and practices learned from the previous modules. The participants reproduce real-time board-proceedings experience combining and mimicking decision-making process, and also covering board discussions on the presented 'Committee' report.


